Keywords: List between 3 and 5 keywords. They will also be used to produce a keyword index.

Abstract. From the abstract onwards, please use Times Roman (Times New Roman) 12pt. Your abstract should be 100-150 words long and summarize the content of the paper. The abstract should be made of only one paragraph. References should not be used in the abstract. Complex chemical formulas should also be avoided. Use the styles in this template to easily conform to the publishers typesetting requirements (e.g. the style for the abstract is called "TTP Abstract").

Introduction

Set the page format to A4 with margins: left, right and top=2 cm, bottom=2.7cm; no header nor footer. Your manuscript will be reduced by approximately 20% by the publisher; please keep this in mind when designing your figures, tables etc.

All manuscripts must be in English. When receiving the manuscript, we assume that the corresponding authors grant us the copyright to use the manuscript for the FuSeM proceedings. Should authors use tables or figures from other Publications, they must ask the corresponding publishers to grant them the right to publish this material in their paper.

Use *italic* for emphasizing a word or phrase. Do not use boldface typing or capital letters except for section headings (see remarks on section headings, below).

The paper should use *SI units* throughout; if other units are customary in the field, they may be added in parentheses.

Organization of the Text

Section Headings. The section headings are in boldface capital and lowercase letters. Second level headings are typed as part of the succeeding paragraph (like the subsection heading of this paragraph).

Page Numbers. Do not print page numbers. The paper should be exactly 4 pages long.

Tables. Tables should be presented as part of the text, but in such a way as to avoid confusion with the text. A descriptive title should be placed above each table. Units in tables should be given in square brackets [meV]. Tables should be centred in the page; only the necessary grids should be traced (see for example Table 1).

Special Signs. They should always be typed with the fonts Times Roman or Helvetica (Arial). **Figures.** Figures (refer to them with: Fig. 1, Fig. 2, ...) also should be presented as part of the

text, leaving enough space so that the caption will not be confused with the text. The caption should be self-contained and placed *below or beside* the figure.

Colour figures are welcome for the online version of the journal. Figures will be reduced to black and white for the print version, unless the author indicates otherwise on the check-list and makes the necessary payments in advance.

Graphs should have a white background for improved visibility (note that this is NOT the default with some graphing programs like Excel).

Equations. Equations (refer with: Eq. 1, Eq. 2, ...) should be indented 5 mm. There should be one line of space above the equation and one line of space below it before the text continues. The equations have to be numbered sequentially, and the number put in parentheses at the right-hand edge of the text. E.g.

$$c^2 = a^2 + b^2$$

Submission as PDF

The submission format is Portable Document Format (PDF). To generate it under *Windows*, you may use proprietary software like Adobe's or you may download the free software *PDFCreator* from *http://www.pdfforge.org/*. PDFCreator allows you to generate a PDF with the same ease as you print to a normal printer. If you use OpenOffice, you may simply export to PDF with the dedicated option in the File menu.

In *Linux*, printing to PDF is supported out-of-the-box in most distributions.

You must also supply the article in the original format of your word processor (i.e. source file).

The maximum file size of the uploaded PDF & source is 2MB each.

Literature References

References are cited in the text just by square brackets [1] or [2,3] or [4-7]. The references are to be numbered in the order in which they are cited in the text and are to be listed at the end of the contribution under a heading *References*, see our example below.

Summary

If you follow the foregoing, your paper will conform to the requirements of the publisher and facilitate a problem-free publication process.
